

## 2018 Property Tax Rates in Harris County Hospital District

This notice concerns the 2018 property tax rates for Harris County Hospital District. It presents information about three tax rates. Last year's tax rate is the actual tax rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers start rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

Last year's adjusted operating taxes (after subtracting taxes on lost property and adjusting for any transferred function, tax increment financing, state criminal justice mandate, and/or enhanced indigent healthcare expenditures)	\$743,393,370
÷ This year's adjusted tax base	\$429,474,661,211
=This year's effective operating rate	\$0.17309/\$100
x 1.08=this year's maximum operating rate	\$0.18693/\$100
+ This year's debt rate	\$0.00108/\$100
= This year's total rollback rate	\$0.18801/\$100

### Statement of Increase/Decrease

If Harris County Hospital District adopts a 2018 tax rate equal to the effective tax rate of \$0.17421 per \$100 of value, taxes would increase compared to 2017 taxes by \$17,035,356.

**Schedule F - Enhanced Indigent Health Care Expenditures**

The Harris County Hospital District spent \$651,623,000 from March 1, 2017 to February 28, 2018 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$0.
